# **Requirements for abstracts registration**

1. The participant has the right to present only one abstract in the collection, which have not been published before.

2. The maximum number of co-authors of one abstract is three.

3. Abstracts are **up to 5 pages** that are not numbered.

4. Format is A4, typeface is MS Word

5. Font - Times New Roman, size -14, line spacing -1.5, paragraph -1.25 cm.

6. Margins: top, bottom, right, left - 20 mm.

7. In the upper right corner - **the author's surname and initials** (in bold), scientific degree, academic rank, position, name of the institution, city, country (for foreigners).

8. Below - in one paragraph - THE TITLE OF THE ABSTRACT (in large, bold letters in the center).

9. Below - in one paragraph - the text of the abstract.

10. Each illustration, diagram, scheme must be captioned, the table must have a title. The format of tables and figures should be only in **book format**.

11. Formulas should be printed using the Microsoft Equation formula editor and numbered in parentheses.

12. At the end of the text - in one paragraph – **the List of references** is given (in bold and in the center). References to the literary source are given in square brackets according to the order of mention. The bibliography should contain only sources that are referenced in the text; example of design of references: [1, p. 45]. References in parentheses to various sources should be given through semicolons ([1; 2]); the literature is formatted in accordance to the latest requirements.

13. The Organising Committee reserves the right to select and edit scientific reports.

14. Materials that do not meet the established requirements will not be considered.

15. In case of detection of signs of falsification, fabrication, plagiarism, self-plagiarism, etc., the editorial board will not accept materials for publication.

<u>N.B. The editorial board reserves the right to final</u> edit or reject material that do not comply with the above requirements. All abstracts of the conference are checked for plagiarism. In case of exceeding 10% of borrowings, theses are not accepted for publication.
